I also understand that I will not be allowed to register for additional classes that generate fees or for future semesters unless the balance owed is paid in full.
- Financial Aid - In the event I receive Financial Aid or other financial assistance, I understand that the College may use those funds to reduce or pay off the balance of my loan before I receive any of the money from such aid. **If I "do not" receive Financial Aid I understand that I am personally responsible for making the payments due on my account according to the above schedule.**
- Processing Fee - I understand that I must pay a non-refundable \$50 processing fee.
- Late Fee(s)- I understand that if I fail to make the scheduled payment by the above due date I will be assessed a \$75 late fee for each late payment.
- Financial Holds - I understand that the College will not issue transcripts and reserves the right to withhold my grades, diplomas, subsequent registration, housing assignments, payroll checks, etc., until my account is paid in full.
- Failure to Pay - I understand that if I fail to make an arranged payment, the College can require immediate payment of the entire balance along with late fees. I understand that the College may refer the account to an outside collection agency. I understand that if the College does place my account in the hands of a collection agency an additional 33% of the outstanding balance will be added to my account.
