Carol with CPE

Carol Vanhoozer the head of counseling services is proposing to make CPE a council itself. She starts by explaining the need for counseling, especially in the time of COVID-19 for anxiety and depression. The foundation is unable to fund CPE's due to the pandemic, but more students are seeking counseling, showing a 25% increase in anxiety for those between 18-24 years old.

Students are professionally trained and are approved from the entire counseling services department. Certified Peer educators improve mental wellness on campus by providing 1:1 conversation. They also help provide presentations across campus in classes, clubs, organizations, and more opportunities with students and staff.

CPE's go through a 12-hour intensive training improving communication, public speaking, and information on different mental illnesses and what they look like.

All members must pass a national certification.
